STUDENT DRESS

1. Authority is vested in the principal (faculty and student council should be included in the process) in inaugurate programs to develop wholesome attitudes, to establish necessary rules, and to adopt standards to accomplish the goals.
2. The Board recognizes and emphasizes the importance of school, parent, and student collaboration in encouraging students to attend school dressed in a neat, clean, safe, and modest manner. Student clothing, accessories and appearance shall be clean and modest, and shall not disrupt class work, cause disorder, or infringe on the rights of others.

THE FOLLOWING STANDARDS APPLY TO ALL STUDENTS:

1. In all areas of the school, students must dress safely and in good taste.
2. Hats will not be worn in the classroom and during the presentation of colors, or other places where hats may be restricted. Hats will be removed during regular instructional classes. Some classes may allow the wearing of hats, i.e. classes held outside, industrial arts classes or other similar locations as determined by the school. Schools should identify, in writing, classes or areas where hats may be allowed.
3. Shoes must be worn. Bare feet are prohibited.
4. No tank tops. Blouses and/or shirts must have sleeves of some type.
5. Shorts and mini-skirts may be worn to school. However, inappropriately short, tight, revealing shorts, skirts or dresses will not be allowed. The guideline is: Shorts and dresses must be the length of one's fingertips when the arm is at his/her side.
6. Shoes or other articles of clothing that would damage school property must not be worn.
7. See-through clothing without undergarments, or the obvious display of undergarments will not be allowed.
8. Clothing exposing any part of the torso: midriffs, halters, or similar wear, will not be allowed.

9. Clothing that is distracting, offensive, vulgar, or in poor taste is prohibited.
10. Clothing that is torn, ripped, or frayed is prohibited.
11. Clean shaven or a well-trimmed mustache and/or beard are permissible.
12. Clothing advertising any illegal behavior for students is prohibited. (i.e. alcohol, tobacco/electronic cigarettes, drugs, sexual innuendoes, etc.)
13. No gang type clothing will be worn to school. (See Safe School Policy, File Code: 6090) Any clothing with symbols of violence will not be allowed, i.e. trench coats, etc.
14. In connection with specialized school-sponsored activities, school officials may permit or require students to wear certain types of clothing, such as uniforms worn at athletic events, cheerleading outfits, protective gear in vocational applied technology classes, etc.

CONSEQUENCES FOR POLICY VIOLATIONS:

The success of any policy is determined by the enforcement of the standards. All staff are to cooperate in administering the policy consistently and fairly. Guidelines are to be followed when violations of the dress code occur.
